TERMS AND CONDITIONS

Juventus F.C. S.p.A. ("Juventus") offers its fans under the age of 30 the opportunity to obtain a free personalized GTT "Daily a data fissa" ticket ("Daily Pass GTT") valid on all GTT urban and suburban transport, as well as on the metro, for an unlimited number of trips throughout the day on which the Juventus – Monza match ("Event") will take place, as part of the "Road to Allianz Stadium" program ("Program"), according to these terms and conditions ("Terms and Conditions").

1. Program Recipients

- 1.1 The Program is offered by Juventus to individuals who:
- (i) hold a subscription or otherwise possess a valid access ticket for the Event purchased within 26 hours prior to the Event,
- (ii) are under the age of thirty at the time of purchase,
- (iii) have an active email address,
- (iv) have accepted these Terms and Conditions (hereinafter referred to as "User(s)").

2. How to Obtain the Free Transport Ticket

- 2.1 Users interested in the Program must hold a valid subscription or ticket for the Event (hereinafter referred to as "**Ticket**").
- 2.2 Subscribers or Users in possession of a Ticket will receive an email from Juventus containing a unique code to redeem the Daily Pass GTT valid for the entire day of the Event.
- 2.3 Each User receiving the unique code as per section 2.2 must access the dedicated page for the Initiative on the official GTT website and enter the unique code to redeem the Daily Pass GTT (provided as a PDF containing a QR Code to be validated on public transport), within 24 hours before the start of the Event.
- 2.4 Once the unique code has been entered on the GTT website, it will no longer be possible to issue additional Daily Passes linked to the same Ticket. In case of name change on the Ticket, the previously issued Daily Pass GTT associated with the original name will no longer be valid and will be forfeited.
- 2.5 The unique code is personal, linked exclusively to the Event Ticket, and can only be used once. It is non-transferable, non-refundable, and cannot be reused in case of name change of the match Ticket.
- 2.6 To activate the Daily Pass, the QR code must be validated on board the public transport vehicles used.
- 2.7 The User must show both the Daily Pass and the Ticket to allow GTT to verify the match between the Ticket holder and the Daily Pass holder. The User acknowledges that failure to confirm this match may result in sanctions imposed by GTT. If the Ticket is dematerialized and uploaded onto a Juventus Card, the User must present the placeholder or a digital substitute printout.
- 2.8 A name change on the Ticket after downloading the Daily Pass will invalidate the Daily Pass. However, if the Daily Pass is downloaded after the name change, it remains valid.

2.9 The Daily Pass can be used in either paper or digital format, but the User must ensure that no other payment methods are activated during QR code validation.

3. Limitations

- 3.1 Failure to comply with these Terms and Conditions may result in the inability to obtain and/or use the Daily Pass GTT and/or the imposition of sanctions by GTT according to its own Daily Pass GTT terms and conditions. Juventus will not be held responsible for the non-receipt of the code by the User due to reasons not attributable to Juventus (including, but not limited to, incorrect email address, full mailbox, spam filters, connectivity issues).
- 3.2 Juventus is solely responsible for delivering the unique Daily Pass code, and the User acknowledges that redeeming, using, and correctly utilizing GTT transport to reach the Event is the sole responsibility of the User.

4. Governing Law and Jurisdiction

- 4.1 These Terms and Conditions are governed by Italian law.
- 4.2 The User can access information regarding the processing of their personal data at this link.
- 4.3 Any dispute arising in connection with the interpretation, validity, and execution of these Terms and Conditions shall be:
- if the User qualifies as a consumer pursuant to Legislative Decree 206/2005, the competent court will be that of the User's place of residence or domicile;
- in all other cases, the Court of Turin will have exclusive jurisdiction.
